Full day, Sunday-Saturday, any number of playing participants (max. 144 – 36 foursomes), up to 56 golf carts included, food service \$6,000

Partial Day

Partial day, Sunday-Saturday, any number of playing participants (max. 144 – 36 foursomes), up to 56 golf carts included, food service

Rental Notes

1. Room rentals are based on a 1-hour minimum; room rates for over 4 hours are set by General Manager or designee.
2. Storage space is not provided during or after rental periods.
3. The pool may be rented during the regular operating season (Labor Day to Memorial Day), outside regular hours of operation, for a minimum of 1 hour at the current, published hourly rental rate. Rentals of one hour only must immediately precede or follow regular pool operating hours. Pool rental for groups, clubs, or for lessons will be by contract.
4. Cost of one lifeguard, to cover the first 25 persons, is included in the hourly rental charge for the pool. An additional hourly fee of \$15 per hour will be charged to cover the cost of one lifeguard per each additional 25 persons.
5. Lifeguard fees are NOT discounted.
6. For areas not defined, there is a \$15 set up and break down per hour (minimum) as necessary.
